**GONE IN 60 ESCAPE GAMES
 RELEASE AND WAIVER FOR LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT WITH PARENTAL CONSENT
 (“Agreement”)**

In consideration of being permitted to engage in the following activity - Attempting to escape from a small, locked room with a group of people which may include, but is not limited to, physical requirements such as crouching, kneeling, crawling, and ducking, mental stress and similar emotions, fragrance, the use of simple tools and objects, periodic dim lighting in rooms, laser light, blacklights, and potentially mature themes (hereinafter referred to as the “Activity”) organized by Red Hat Enterprises, Inc. dba Gone In 60 Escape Games located at 1028 SW Adams Street, Suite 101, Peoria, IL 61602.

I acknowledge and agree to, on my own behalf, and on behalf of my personal representatives, heirs, assigns, executors, administrators and next of kin, as follows:

Upon entering the Activity Premises, I will inspect the same and my observation and my engagement, participation and/or involvement in the Activity shall constitute an acknowledgement that I find and accept them to be safe and reasonably suited for their intended purpose. This waiver shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I agree to allow my photo, video, or film likeness to be used for any legitimate purpose this authorizing entity decides, and assigns. I give Red Hat Enterprises, dba Gone In 60 Escape Games, all rights to market, publish, reproduce (in any and all media), and otherwise use the recordings without my permission. I acknowledge that I am not permitted to take photos or recordings while participating in the activity described above. I acknowledge that the intellectual property I become aware of cannot be replicated or shared.
